Executive Director/Administrator: In addition to the report submitted, Raymond Hughes welcomed Geoffrey Soriano, the new Director of the Somerset County Park Commission.

Fund Attorney - Claims Management & Litigation: No additions to the report submitted.

Fund Attorney – Regulatory Compliance & Legislation: In addition to the report submitted, Fund Attorney Berry announced that legislation has passed both houses and is on the Governor's desk which broadens investment opportunities for joint insurance funds in the State of New Jersey. Discussion followed.

Further, Fund Attorney Berry reviewed legislation that allows individuals to take action against insurance companies for unpaid claims. Public entities have been removed from that equation and the insurance industry is trying to amend it. Discussion followed.

Third Party Administrator: No additions to the report submitted.

Arrival of Commissioners Brian D. Levine and Daniel J. Livak were acknowledged at this time.

Custodian of Funds: No additions to the report submitted.

Actuary: Eric Bause of The Actuarial Advantage addressed the Board regarding analysis of the Somerset County Joint Insurance Fund's net loss and allocated loss adjustment expense reserves, as well as the projected Incurred But Not Reported (IBNR) losses. The complete findings are contained in his report entitled, *The Somerset County Joint Insurance Fund Actuarial Analysis of Loss and Loss Adjustment Expense Reserves as of 12/31/17*.

Auditor: Robert Butvilla of Suplee, Clooney and Company stated that the report entitled, *The Report of Audit on the Financial Statements of the Somerset County Joint Insurance Fund for Years Ended December 31, 2017 and 2016* was clean, as noted in the final page with no Comments or Recommendations.

The Loss Prevention/Loss Control Safety Audits for Fund Members annual inspections at entity locations have been scheduled by Mark Worthington of T&M Associates. Following inspections, reports are issued and each Fund Member will have 60 days to submit a written response to any recommendations contained in the report. Compliance is one component of the Safety Incentive Program.
