SERVICE PROVIDER REPORTS

Executive Director/Administrator: Raymond Hughes, New Jersey Risk Managers & Consultants, Inc. provided an overview of the updated Executive Director Report and explained the reason for a deficit contained in the report and indicated that this is due to the IBNRs (claims incurred by not yet reported). However, he mentioned that these numbers will improve as they have in previous years and commended the Fund for their great work.

Fund Attorney - Claims Management & Litigation: In addition to the report submitted, Fund Attorney Stephen O. Davis stated that he would comment during closed session.

Fund Attorney – Regulatory Compliance & Legislation: In addition to the report submitted, Fund Attorney M. Paige Berry elaborated on recent decisions favorable to public entities and new legislation enacted. She also discussed the Memorandum issued in September of 2018 by the Office of the Attorney General relating to municipal prosecutors' discretion in prosecuting marijuana offenses.

Safety Committee: Maryjane Hydro, New Jersey Risk Managers & Consultants, Inc., provided an update of the recent Safety Committee Meeting which was held at the Township of Green Brook on Tuesday, September 11, 2018. She also informed everyone that per Brielle Schulz from Somerset County Emergency Services Training Academy, a syllabus is being adapted for a chainsaw training. However, there has been a delay as the trainer drafting the syllabus is a member of NJ Task Force One and has been called to assist with Hurricane Florence Relief. Upon his return, training will be finalized and invitations will be sent out.

On Tuesday, October 30, 2018 a seminar entitled "Training for Liability, Property and Workers' Compensation Claim Reporting & Intake Procedures" will be held for Administrators, Managers, Supervisors and HR Department Heads. Panelists will include Concentra, who will be demonstrating access to their new computer platform for the transition of US HealthWorks locations in Bridgewater and Somerset, New Jersey, which are frequented by SCJIF employees for WC injuries.

T&M Associates has completed the Loss Prevention & Loss Control Safety Audits throughout the Fund Membership. Where written reports have been issued, Members have 60 days to complete their written response regarding those items which have been identified during the inspections.

The next scheduled regular Safety Committee meeting will be held at 9:00 a.m. on Tuesday, October 2nd, at the Somerset County Vocational and Technical School/Trade Wins Restaurant.
