SERVICE PROVIDER REPORTS

Executive Director/Administrator: In addition to the report submitted, Raymond Hughes, New Jersey Risk Managers & Consultants, Inc. provided an overview of the updated Executive Director Report with recent developments and indicated that two new entities have shown an interest in joining the Somerset County Insurance Joint Insurance Fund. In reviewing their loss experience, they both appear to be a very attractive

risks and would certainly be a good addition to the Fund. New Jersey Risk Managers will keep the Fund appraised of the new developments.

Maryjane Hydro, New Jersey Risk Managers & Consultants, Inc. provided an overview of the Return of Surplus and the member dividends. The dividend distribution will take place during the month of December.

The 2019 Auto ID Insurance Cards and Workers Compensation Posting Notices were distributed to all Fund members.

Furthermore, the Somerset County Joint Insurance Fund (SCJIF), pursuant to the Fair and Open process will be soliciting Request for Proposals for professional services, which will be posted on November 29, 2018 in *The Courier News, The Hunterdon Democrat* and the SCJIF's website (http://scjif.org). She also noted that the Somerset County Joint Insurance Fund will be launching a new website on the morning of November 29, 2018, and invited everyone to visit the site.

The proposed 2019 SCJIF Fund Commissioner's Meeting Calendar was distributed and any scheduling conflicts should be noted prior to adoption at the January 2019 SCJIF Reorganization Meeting. The Fund Commissioner's next meeting will be held on Wednesday, December 19, 2018 at the Somerville B.P.O. Elks Lodge #1068.

Fund Attorney - Claims Management & Litigation: No additions to the report submitted.

Fund Attorney – Regulatory Compliance & Legislation: In addition to the report submitted, Fund Attorney, M. Paige Berry, expanded on two recent decisions contained in her report and stressed the importance of having policies in place to cover different exposures in the workplace.

Safety Committee: In addition to the report submitted, Maryjane Hydro, New Jersey Risk Managers & Consultants, Inc., advised that the Safety Committee met on October 2nd and November 5th.

The 2018 Safety Incentive Program will be concluding on December 31st. All qualifying submissions should be forwarded to T&M Associates and/or New Jersey Risk Managers.

As a result of recent loss inspections along with claim trending, a Training Seminar was conducted on October 23rd for Machine Guarding & Hand Safety, with approximately 50 employees from the various Fund Members in attendance. On October 30th a Seminar was held for Supervisors, Managers, and Department Heads for Liability, Property and Workers' Compensation Claim Reporting and Intake Procedures. Javier Esparra from New Jersey Risk Managers reviewed AL, GL & Property, Jackie Fresco & Lisa Gallo from Qual-Lynx explained WC, and representatives from Concentra, discussed the final phase of the transition of USHealthworks to Concentra and demonstrated the new computer platform access for Human Resources. Approximately 60 employees attended this seminar. Employment Practices Liability Training will be held on Tuesday, December 11th at the Borough of High Bridge and all Fund Members are welcome to attend.

As a result of discussion at the last meeting arrangements have been made for the Safety Committee Members to participate in "Stop the Bleed" Emergency Trauma Training which will be held as the January Safety Committee Meeting and take place at the Somerset County Emergency Services Training Academy.

The next scheduled meeting will be Tuesday, December 4th, at 9:00 a.m. at the Somerset County Vocational & Technical Schools TradeWins Restaurant.

NEW BUSINESS

Raymond Hughes, New Jersey Risk Managers, provided an overview of the Preliminary Budget for the 2019 Fund Year. The negotiating stages are still ongoing with the carriers at this time and the figures are subject to change. The Preliminary Budget shows an increase of approximately 2% compared to the 2018 Budget. The amended budget will be introduced in March of 2019 and it will contain all final negotiated figures and operating expenses. Despite the 2% increase, he reiterated that the Somerset County Insurance Fund is the only Fund in the State that has been able to continuously return dividends to its members. He also thanked Lucy Martins, New Jersey Risk Managers, for her hard work in assisting with the Preliminary Budget.
