Executive Director/Administrator: In addition to the report submitted, Raymond Hughes briefly noted that the Report did not include the Incurred But Not Reported Reserves (IBNRs) as those figures will be completed by the Actuary later in the year and will be incorporated accordingly.

Fund Attorney - Claims Management / Litigation: No additions to the report submitted.

Fund Attorney – Regulatory Compliance / Legislation: Fund Attorney Berry highlighted some of the cases contained in her Report and also discussed recent amendments to the Legislation that will impact public entities.

Because some of the changes discussed by Fund Attorney Berry can have an adverse effect on our Fund, Actuary Eric Bause briefly explained how the Fund can address and allocate funds for claims which the statute of limitations has been either extended or no statute of limitations exists. Various questions were raised and discussion followed.

Third Party Administrator: No additions to the report submitted.

Custodian of Funds: No additions to the report submitted.

Actuary: Eric Bause of The Actuarial Advantage addressed the Board regarding analysis of the Somerset County Joint Insurance Fund's net loss and allocated loss adjustment expense reserves, as well as the projected Incurred But Not Reported (IBNR) losses. The complete findings are contained in the *Statement of Actuarial Opinion* dated May 9, 2019.

Auditor: Robert Butvilla of Suplee, Clooney and Company stated that the report entitled, *The Report of Audit on the Financial Statements of the Somerset County Joint Insurance Fund for Years Ended December 31, 2018 and 2017* was clean, as noted in the final page with no Comments or Recommendations

COMMITTEE REPORTS

Safety Committee: In addition to the Report submitted, Maryjane Hydro stated that the Safety Committee met on April 2nd and May 7th, 2019 and advised that the respective Meeting Minutes were included in the package previously distributed.

Furthermore she was pleased to announce that members of SCJIF and its employees will now have access to On-Line Safety Training, a very important safety training tool, which can be accessed through the SCJIF website (http://scjif.org). One of the benefits of this new training tool is that those who cannot physically attend the seminars offered throughout the year by the Fund will be able to take the on-line training courses at their convenience. There are currently approximately 300 courses available to Fund employees in the expansive library on a wide range of topics. NJRM will monitor course completion and will be able to provide periodic reports to Safety Representatives and Administrators.

A SCJIF Safety Seminar entitled, "Office Safety & Cleaning, Ergonomics, Slips and Walking/Working Surfaces Training" was held at Raritan Valley Community College on Tuesday, April 16th, 2019. There were approximately 25 employees in attendance. Similarly, the package also included a handout for last minute registrations for an upcoming SCJIF Safety Training Seminar entitled, "OSHA Hazard Assessment" presented by Mark Worthington of T&M Associates to be held on Thursday, May 23rd, 2019 at the Somerset County Park Commission at 9:00 A.M. Maryjane Hydro explained that "Job Hazard Assessment" is a technique used to identify the dangers of job duties and tasks as well as measures necessary to reduce the risk of injury and unsafe working conditions. In light of the significance of this subject, she encouraged participation and attendance.

Everyone was also reminded that the Safety Recognition Breakfast will take place on Tuesday, June 11th, 2019 at the Somerville B.P.O. Elks Lodge #1068 at 9:00 A.M. The support of the Commissioners and Alternate Commissioners would be greatly appreciated for this important event. Furthermore, the Committee will be on summer hiatus until Tuesday, September 10th, 2019, reconvening at the Township of Green Brook.
