Also, the timeline for the SCJIF Fair and Open process for soliciting Request for Proposals for Professional Services the 2021 Fund Year was provided. Fund Attorney – Regulatory Compliance / Legislation: In addition to the report submitted, Fund Attorney Berry elaborated on a case concerning an appeal of the dismissal of a claim under the New Jersey Civil Rights Act (NJCRA) and the denial of attorney fees under NJCRA. Discussion followed.
