SERVICE PROVIDER REPORTS

Executive Director/Administrator: Maryjane Hydro stated two Members, the Borough of Raritan from Somerset County and the Borough of High Bridge from Hunterdon County are non-renewed as of January 1st, 2021. Both of these members were in the Somerset County Joint Insurance Fund for one term and returned to their former joint insurance funds. Discussion followed on the philosophy of fiscal responsibility for the management and success of the SCJIF.

In addition to the report submitted, Maryjane Hydro welcomed any questions and/or comments.

Fund Attorney - Claims Management / Litigation: No additions to the report submitted.

Fund Attorney – Regulatory Compliance / Legislation: In addition to the report submitted, Fund Attorney Berry elaborated on recent case law regarding First Aid Squad Responders charged with negligence.

Additionally, there was review of S771 pending Workers' Compensation Legislation which would amend law to provide that an injury is compensable if it occurs in a parking area provided or designated by the employer or if it occurs when an employee is traveling directly between the parking area and the place of employment.

Third Party Administrator: No additions to the report submitted, however, Mr. Javier Esparra welcomed questions from the Fund Members.

Custodian of Funds: No additions to the report submitted.

COMMITTEE REPORTS

Safety Committee: In addition to the report submitted on behalf of Committee Chair Sipple, Maryjane Hydro of NJRM, advised that the SCJIF Safety Committee met telephonically on January 12th, 2021. New Jersey Risk Managers shared electronically and included in the package the January JIFNEWS Quarterly Newsletter focusing on Safety, Health & Wellness.

The Committee had a discussion and review of Maggie's Law along with a reminder of the personal implications to employees about driving while sleep deprived. Sample policies were provided to the Safety Representatives.

Appropriate personnel responsible for completing OSHA300 forms for each Fund Member were provided data capturing employee's lost time during the 2020 calendar year. As a reminder, these reports have been provided as a <u>tool</u> to be utilized in calculating what is OSHA reportable for each entity.

There was discussion on the need to have the Department Heads of the various SCJIF Fund Members receive training on Workers' Compensation First Report Of Injury (FROI) paperwork and the process. Additional information will be forthcoming to address this request.

The next scheduled safety meeting will be held telephonically on Tuesday, February 2nd at 9:00 a.m.

Claim PAR Committee: Committee Chair Trojan stated that the Committee met on January 19th, 2021 and the Meeting Minutes were submitted in the Meeting Package. Actions will be ratified during the Old Business portion of the Agenda.

Finance/Contract Committee: Committee Chairperson Gregory Bonin informed all in attendance that the Committee met via Zoom on January 14th to review the 2021 Service Provider Request for Proposal (RFP) submissions. A summary of the recommendations was contained in the report submitted and was further provided by Commissioner Bonin. Contracts and letters will be issued in accordance with the recommendations.
