**Executive Director/Administrator:** No additions to the report submitted, however, Raymond L. Hughes II welcomed any questions or comments.

Fund Attorney – Regulatory Compliance / Legislation: In addition to the report submitted, Fund Attorney Berry elaborated on recent case law regarding New Jersey's Conscientious Employee Protection Act (CEPA) as well other cases pending before the New Jersey Supreme Court and Appellate Division.

Attorney Berry also provided an extensive review of pending legislation S3375, A2617/S2998, S2607, A-21, S2535 and Daniel's Law. She explained how each of these Bills, if passed, would have an impact on public entities.

Third Party Administrator: In addition to the report submitted, Mr. Javier Esparra welcomed questions from the Fund Members.

Custodian of Funds: No additions to the report submitted.

#### COMMITTEE REPORTS

Safety Committee: In addition to the reports submitted on behalf of Committee Chair Sipple, Maryjane Hydro of NJRM, advised that the SCJIF Safety Committee met telephonically on February 2, 2021 and March 2, 2021 and the respective Meeting Minutes were included in the Package.

As previously informed, the Fund will be conducting a Training Seminar on Tuesday, March 30th, 2021 entitled "Accident & Incident Investigations and FROI Reporting" for Supervisors and Department Heads to receive proper training for completion of Workers' Compensation First Report of Injury (FROI) forms and the process of investigating and reporting work-related injuries. This Seminar will be conducted via Microsoft Teams and presented by the Fund's Safety Consultant, Mark Worthington and Javier Esparra from NJRM. NJRM encourages distribution of the Invitation and participation in this very important training.

Also included in the Package is the April JIFNEWS Quarterly Newsletter which focuses on mental health and provides information to the various resources for mental health in the State of New Jersey as well as Somerset and Hunterdon Counties. Circulation, printing and posting of the JIFNEWS is strongly encouraged as the information contained therein is vitally important for families during the continued Governor's public health emergency.

The 2020 Workers' Compensation Year-End Trend Analysis and Evaluation for the overall Fund has been provided to all Entity Members. Individual Fund Members can access their information thru the Fund's website (<a href="http://scjif.org">http://scjif.org</a>). Safety Consultant, Mark Worthington of T&M Associates also commended the Fund Members for the extraordinary work as the Total Claims Costs are significantly down from previous years despite the frequency of claims and the challenges we are all facing due to the pandemic. He contributed the positive results to the hard work of all Safety Committee Representatives by sustaining the safety culture in each of their individual entities, as well as the support and assistance of New Jersey Risk Managers. Questions were welcomed.

The next scheduled safety meeting will be held telephonically on Tuesday, April 6<sup>th</sup> at 9:00 a.m.

Claim PAR Committee: In addition to the reports submitted, on behalf of Committee Chair Soriano, Ms. Hydro advised that the results of the Claim PAR Committee Meetings will be ratified during the Old Business portion of the Agenda.

Legislative Committee: Fund Attorney Berry advised that the Legislative Committee met telephonically on March 3, 2021. After detailing the particulars regarding the pending legislation, is it the recommendation of the Legislative Committee to oppose pending legislation S3375 and A2617 which, if enacted, would radically alter the practice of Workers' Compensation with respect to medical control and communications regarding medical issues. The Committee recommends the Fund Attorney and Executive Director to forward opposition letters and, if necessary, to present written and oral testimony in further opposition of S3375 and A2617. Attorney Berry advised that she will continue to monitor and report to the Fund of any Bills that would impact the Fund.

Additionally, Ms. Hydro offered comments that NJRM has joined a collaborative coalition of public and private self-insured entities, attorneys and service providers in the Workers' Compensation industry who are likeminded in their concerns regarding the opposition of S3375 and A2617.
