SERVICE PROVIDER REPORTS

Executive Director/Administrator: In addition to the Report submitted, Mr. Raymond L. Hughes II welcomed questions.

Additionally, Ms. Maryjane Hydro, NJRM advised that 2023 Auto ID Cards, 2023 Workers' Compensation Posting Notices have been distributed to all Fund Members. This year updated Auto ID Cards holders were also distributed.

The timeline for the SCJIF Fair and Open process for soliciting Request for Proposals were posted on November 10, 2022 in the Courier News, The Hunterdon Democrat and on the Fund's website. The deadline to submit Responses is Friday, December 2, 2022.

Ms. Hydro also reminded everyone that a training seminar for Administrators, Managers, Supervisors & HR Department Heads entitled "Employment Practices Liability Training" sponsored by CHUBB Insurance will be presented by Attorney Amber Spataro, Esq. of Littler Mendelson, PC on November 30th, 2022 at 10:00 AM the Somerset County Park Commission in Bridgewater, NJ.

Additionally, the proposed 2023 Meeting Schedule was distributed as part of the Meeting Package. Any conflicts or changes should be requested as soon as possible prior to the adoption at the January 2023 SCJIF Reorganization Meeting.

Fund Attorney – Regulatory Compliance / Legislation: In addition to the Report submitted, Fund Attorney Berry advised that the State Department of Banking and Insurance issued a letter of approval for the Return of Surplus, a copy of which was distributed to all Fund Members. Attorney Berry also elaborated on Directive # 2022-14 issued by the New Jersey Office of Attorney General regarding "Transparency in Internal Affairs Investigations". A summary of the full Directive was distributed to the Commissioners. The entire directive will be distributed electronically to the Funds Members. Discussion followed.

COMMITTEE REPORTS

Safety Committee: In addition to the Report submitted and on behalf of Committee Chair Sipple, Ms. Maryjane Hydro of NJRM advised that the Safety Committee met on October 4, 2022, and November 1, 2022, and the respective Minutes were included in the Meeting Package.

On October 26, 2022, the Fund's Safety Consultant Mark Worthington presented a training seminar entitled "Work Zone Safety" at Raritan Valley Community College and approximately 82 employees were present. The information discussed during the training seminar has also been posted on the Fund's website.

Additionally, Stu Schwerner, Senior Director, Community Outreach & Workers' Compensation provided an overview of the personalized treatment for work-related injuries and physical therapy services offered by JAG-One Physical Therapy during the November Safety Committee Meeting. Highlights of his presentation included: benefits of physical therapy, what physical therapists do, services offered at the various JAG-One locations (Education & Injury Prevention; Physical & Occupational Therapy; Sports Medicine among others). Ms. Maryjane Hydro also advised that if requested, additional presentations can be held and tailored to each individual Entity and its needs.

Ms. Hydro also reminded everyone that the 2022 Safety Incentive Program will conclude on December 31, 2022 and asked that submissions be forwarded as soon as possible to either New Jersey Risk Managers and/or T&M Associates.

The next scheduled SCJIF Safety Committee Meeting will be held on Tuesday, December 6th, 2022, at 9:00 a.m. at the Somerset County Vocational & Technical Schools TradeWins.

NEW BUSINESS

Raymond L. Hughes, New Jersey Risk Managers, provided an overview of the Preliminary Budget for the 2023 Fund Year. He added that the insurance market remains in a "Hard Market" coupled with inflation resulting in high single to double digit increases. Despite these challenges we are anticipating a 6.8% increase and assured Fund Members that negotiations are ongoing and this figure may improve. Mr. Hughes further explained that property carriers are affected by recent Hurricanes Ida, Ian and Nicole in their insurance pricing. As a result, property insurance markets are factoring significant increases in the cost of construction coupled with inflation to calculate property replacement costs for covered claims.

With respect to Professional Liability Insurance Policies which contain Employment Practices Liability Coverage, Mr. Hughes added that NJRM is negotiating with carriers to retain the current retentions on the Professional Liability and Employment Practices Liability Coverages. New Jersey Risk Managers is continuing to work with our carrier regarding higher retentions for Law Enforcement Employment Practices Liability matters. Additional information with be forthcoming as soon as available.
