**Executive Director/Administrator:** In addition to the Report submitted, Ms. Barbara Murphy advised that New Jersey Risk Mangers is currently reviewing Financial Statements which will be presented to the Board at a later date.

Fund Attorney – Regulatory Compliance / Legislation: In addition to the report submitted, Fund Attorney Berry provided additional details and information on the caselaw included in her Report.

#### **COMMITTEE REPORTS:**

**Safety Committee:** In addition to the report submitted, Ms. Maryjane Hydro stated that the Safety Committee met on February 7<sup>th</sup>, and March 7<sup>th</sup>, 2023 and the Minutes from these Meetings were included in the Meeting Package.

She further advised that New Jersey Risk Managers along with our partners Guardian Public Entity Claim Services (GPECS) and First MCO presented a seminar via Zoom Videoconferencing for Administrators, Managers, Supervisors and Department Heads of the various SCJIF Fund Members providing training on processing of Liability & Property Claim Reporting and Workers' Compensation First Report of Injury (FROI) forms. The information presented explained the purpose and intent of all forms. In light of this, effective March 1<sup>st</sup>, 2023 claim filing documents have been updated and distributed electronically to the appropriate personnel in each Entity. New Jersey Risk Managers is requesting that the new forms be shared internally with the various departments within each individual organization. Due to this change, all previous claim filing documents are to be destroyed and replaced with the amended forms. The following updated form are also available on the SCJIF website.

On March 7<sup>th</sup>, 2023 PEOSH Occupational Safety Consultant, Ms. Sandra Clanton from the New Jersey Department of Labor & Workforce Development conducted a PowerPoint Presentation on the commonly cited hazards. Ms. Clanton explained that the State's PEOSH Program offers free training and consulting programs. Safety Representatives received a Course Catalog of Occupational Safety Training which was also posted on the SCJIF Website.

Additionally, the Fund's 2023 first quarter training seminar entitled "Emergency Preparedness" was presented by the Fund's Safety Consultant Mark Worthington of T&M Associates on March 14<sup>th</sup>, 2023, via Zoom Videoconferencing. Approximately 32 employees participated in this seminar and the PowerPoint Presentation has been posted on the SCJIF website. As a result of this presentation, Emergency Action Plans for all Fund Members are being complied for review and discussion.

A copy of the JIFNEWS Volume 14, Issue 2, April 2023 containing valuable information for recognizing hidden dangers in the office environment was also included in the Meeting Package.

The next regular SCJIF Safety Committee Meeting is scheduled for 9:00 A.M. Tuesday, April 4<sup>th</sup>, 2023, at the Somerset County Vocational & Technical Schools TradeWins Restaurant.

The 2022 Year-End Workers' Compensation Claim Trend Analysis & Evaluation has been provided to each Entity and is available on the Members Only portion of the SCJIF website. Safety Consultant Mark Worthington of T&M Associates provided an overview of the Trend Analysis. He noted that the "Total Net Paid to Date" figure for all locations is trending down and commended the Fund for maintaining the safety culture. Questions were welcomed.

Claim PAR Committee: Committee Chairperson Soriano stated that the Committee met on February 22<sup>nd</sup>, 2023 and the Meeting Minutes were submitted in the Meeting Package. Actions will be ratified during the Old Business portion of the Agenda.
